#### Instruction to the Applicants for Renewal of Enlistment under HED

- 01. Contractor(s)/Construction Firm(s) desire for Renewal of Enlistment under HED may purchase Application Form from the Office of the Chief Engineer, HED at the cost of non refundable Tk. 100.00 (One hundred) only for each set in favour of Chief Engineer, HED in the Form of Pay Order/Bank Draft from any Scheduled Bank of Bangladesh.
- 02. Each page of the Application Form for renewal and related papers shall be signed & sealed by the applicant or person duly authorized, without which the information contained in that page of application will not be considered.
- 03. Intending contractor shall have to deposit Tk. 2000.00 (Taka two thousand) for Renewal Fee in favour of Chief Engineer, HED in the form of Pay Order/Bank Draft from any Scheduled Bank of Bangladesh.
- 04. All relevant documents such as work order, work completion certificate, payment certificate etc. furnished along with the Application Form must be duly attested by not below the rank of Executive Engineer. State the reasons for not participating/working in the last financial year.
- 05. For any clarification regarding Renewal of Enlistment Form, the applicant may contact with the SE (P&A), HED, Head Office.
- 06. (a) If any information, statement, certificate as furnished by the Applicant is found to be false or incorrect, the application shall not be considered for Renewal of Enlistment.
  - (b) If any information, statement or certificate is found to be false and incorrect at any time even after finalization, the renewal will be treated as canceled.
- 07. Performance will be evaluated on the basis of the information and documents furnished by the applicant and official record of the HED.
- 08. The license approving authority may conduct any investigation to verify the statements, documents, information etc. if and when required and found any misrepresentation or untrue/unjust statements, then the application will not be considered.
- 09. Performance of the Contractor/Construction firm shall be reviewed for last financial year during which the contract management, implementation and overall discipline will be taken into consideration. List of completed and ongoing works to be submitted as stated in the Application Form for Renewal of License.

10. Contractor/construction firm among the enlisted contractors may be short listed for any special/ emergent nature of works basing on the performance of previous year.

This will be notified later from the Head Office, HED.

11. The guidelines for the aided projects of the concerned financing agency shall be

followed in addition to the existing regulation on Public Procurement Rules (PPR).

12. Applicants shall have to provide the list of firms having relation with the applicant

(such as Father, Mother, Brother, Sister, Son, Daughter, Husband & Wife) who are already enlisted under CMMU/HED as per prescribed format attached in the

Application Form for Renewal. If, any fact is suppressed and subsequently detected

as false/misrepresentation, application will not be considered.

13. Considering all the facts, information and performance record, the license approving

authority reserves the right to renew and not to renew any Contractor/Construction

firm without assigning any reason whatsoever.

14. For upgradation of category of license, a separate application form to be submitted

after duly filled up by the applicant.

15. The change of business or present address, telephone numbers or any other important

information must be notified to the Chief Engineer, HED.

16. Any influence or attempt to influence in the process of renewal of enlistment will be

treated as disqualification of the contractor/construction firm.

17. Recommendations of local XEN and his SE of Circle are obligatory where

maximum works in the last financial year remain incomplete or partially completed

or fully completed.
